1. This writ petition has been preferred with the following
prayers:

*"1. By an appropriate writ, order or direction, the
respondents authorities directed to give joining to the
petitioners on the post of Gram Panchayat Shayak in
pursuance of order dated 02.01.2018 and further
more action undertaken by the respondents in
pursuance to the same, for holding the fresh selection
of Gram Panchayat Shayak, on the post of the
petitioners, in Gram Panchayat Ganwar, may kindly
be declared illegal and be quashed and set aside.*

2. Further, it is prayed that the respondents may be restrained from terminating the services of the petitioners from the post of Gram Panchayat Shayak in Gram Panchayat Ganwar and from holding the fresh selection on this post, and if any such order is passed by the respondent during the pendency of the writ petition, the same may kindly be declared illegal and be not effective on the rights of the petitioners and be quashed and set aside.

3. Further it is prayed that respondents may be directed to continue the petitioners on the post of Gram Panchayat Shayak as per their order dated 02.01.2018.

4. Any other appropriate writ, order or direction which this Hon'ble Court deems just and proper may kindly be passed in favour of the petitioner.

5. Writ petition filed by the petitioner may kindly be allowed with costs."

2. At the outset, learned counsel for the petitioners states that the petitioners would be satisfied if their representation is considered and decided by the respondents.

3. In light of the statement of counsel for the petitioners, the writ petition is disposed of with the direction to the respondent to consider and decide the representation of the petitioners by a speaking order strictly in accordance with law within a period of 15 days from today.
